Spotlight On... Officer H.K. Slade

Last month, the Triangle Community Foundation selected Officer H.K. Slade of the Southwest District as their most recent "Champion of Giving Back," an honor that recognizes local individuals who are dedicated to serving their communities. The TCF selected Slade for the award because of his work with Bushido Women's Self Defense, an all-volunteer organization that teaches women practical self-defense skills.

Ten years ago, Slade discovered that there were very few opportunities available for women who wanted to learn how to effectively defend themselves against an attacker; the self-defense books and classes tailored to women mainly involved physical techniques that were hard to master and could potentially be difficult to remember during an attack. So he decided to seek out the advice of the experts at the Association for Women's Self Defense Advancement, a non-profit organization dedicated to furthering awareness of self-defense and rape prevention.

New, Improved RPDnet To Go Live on March 28

On March 28, the new version of RPDnet, with a restructured design and expanded features, will become available to all RPD personnel.

For over a year, members of the RPD's Information Services Team and Public Affairs Office, guided by officer input, have been working on expanding and improving Department's existing Web-based intranet site, which was created several years ago by Senior Officer J.T. Maultsby. RPDnet began as a

Slade attended the AWSDA's yearly national conference, met several nationally-recognized self-defense instructors, and began to train with them. In 2003, he founded Bushido Women's Self Defense with a co-worker, Heather Fox, and they taught self-defense seminars and demonstrations at recreation centers, schools, and other venues on a volunteer basis, investing any funding from class registration fees back into the program.

Eight years later, Bushido Women's Self Defense has seven volunteer instructors, including Master Officer J.D. Fox of the North District and Officer E.M. Reeves of the Southeast District, and the organization offers a variety of courses, seminars, intermediate classes, demonstrations, and safety presentations. According to Slade, the goal is to teach women the skills they need to guard themselves against attack without teaching a specific series of movements that might easily be forgotten in a stressful situation. "Our entire focus is stopping sexual assault," said Slade. "The techniques that we teach are very simple to do and are very close to instinctual."

Slade says that a typical class begins with classroom instruction and discussion about topics such as situational awareness, verbal assertiveness, and the psychological aspects of being involved in a physical confrontation. The second half of the class involves hands-on activities to teach the participants how to gain advantage over a larger and stronger attacker. During some of the courses, the women get to try out their new skills on a padded assailant.

"We get a lot of requests to just teach the physical techniques, but we never do that without first teaching the verbal skills and how to avoid a situation where the last remaining course of action is to fight," said Slade.

Slade says that some women are hesitant to take a self-defense class because they feel protected by the men in their lives or by other factors, such as their dogs, alarm systems, or weapons they carry for protection, but he encourages all women to learn more about how to keep themselves safe.

"The truth is that even if a woman has an awesome husband, brother, father, or other man who she feels protected by, he's not going to be with her every minute of every day," said Slade. "It's the same way with a gun or an alarm or a dog—sometimes those things aren't there, or they don't work. Learning self-defense skills provides another layer of protection."

When Slade founded Bushido Women's Self-Defense, he was working in the hospitality management field, but his work with teaching self-defense led him to seek a new career in public safety. After graduating from Basic Law Enforcement Training and spending a year as a member of the Meredith College Campus Police, Slade joined the RPD in August 2010. After graduating from the 101st Lateral Academy, Slade was assigned to the Southwest District, where he currently serves on A Squad.

list of links to district-specific information, such as most wanted lists, and as personnel from different divisions realized how many officers were using it on a regular basis, more links were added. Currently, all RPD personnel can pull up RPDnet and click the links to sign up for in-service training, access City e-mail, check warrants from several different agencies, and search RPD's trespass file, among other things.

According to Systems Analyst Nick Newbill, who developed the new RPDnet, and Public Affairs Specialist Laura Hourigan, who created the new "RPD News" section, the main idea behind changing the site was to decrease the number of emails sent out department-wide by expanding the capabilities of RPDnet. The goal, they say, is to put nearly all of the information that is currently distributed via mass e-mail onto RPDnet to reduce the amount of e-mail RPD employees receive on a daily basis.

"The purpose of the redesign is not to replace RPDnet, but to improve on an already crucial resource," said Hourigan. "It will be the go-to site for all of the Department's information."


The new RPDnet's home page features a "Common Links" section that lists many of the links that are on the current RPDnet. New to the home page is a listing of high-priority BOLOs, as well as a "Must Reads" section for important information that all personnel are required to review. Links to NCAWARE, CJLEADS, ERP, and the Pilot Daily form are easily accessed at the top of the page, and by clicking the "Theme" link in the upper right corner, users can switch the page's color scheme to make it more easily readable in daylight or darkness.

An array of drop-down menus under the RPDnet banner point to pages featuring division- and district-specific information, along with bulletins from the Raleigh Intelligence Center, computer support links from the Information Services Team, and RPD news from the Public Affairs Office. The new "BOLOs" section features a search capability for both active and archived BOLOs.

According to Newbill, a link to the old version of RPDnet will be available on the new site for a limited time, so that any resources that users may not be easily able to find on the new RPDnet can still be accessed quickly. Newbill says that the link to the old site will not be around for very long, and he encourages RPD members to contact him if they find that a particular link on the old RPDnet is not included in the new version.

"Our police resources on RPDnet are getting a much-needed facelift, but we want to make sure that everyone can still find what they need," said Newbill. "I also invite feedback about things people think should be added or changed."






Chief's Office Conducts Formal Inspection

On February 7, Major S.M. Deans announced the selection of two officers to the Gang Suppression Unit, two officers to the Traffic Enforcement Unit, and one officer to the Crash Reconstruction Unit. These transfers will take effect on Saturday, March 12.

Master Officer E. Camacho has been selected to the Gang Suppression Unit. Camacho joined the RPD in February 2005. After his graduation from the 85th Academy, Camacho was assigned to C Squad in the Southwest District, where he now serves as a police training officer and district gang liaison. Since joining the Department, Camacho has earned his associate's degree in criminal justice from the University of Phoenix. Camacho was born and raised in Bronx, N.Y., and at the age of 18, he joined the U.S. Army's 82nd Airborne Division. During his military service, he was deployed to Afghanistan and Iraq. Camacho received a combat jump badge and a Silver Star for his actions in Afghanistan.

Senior Officer M.S. Caron has been selected to the Traffic Enforcement Unit. Caron joined the RPD on August 19, 2002. After graduating from the 80th Session of the Raleigh Police Academy, Caron was assigned to the Northwest District's A Squad, where he currently serves as a police training officer and the assistant team leader for A1 Squad. Caron grew up in West Haven, Conn., and joined the U.S. Marine Corps after graduating high school. During his military service, Caron managed approximately \$800 million worth of highly explosive ordnance and weapons systems and was stationed in South Korea for one year. Caron separated from the Marine Corps in 2001 and worked as a corrections officer at Central Prison before joining the RPD.

Master Officer A.P. Carpenter has been selected to the Gang Suppression Unit. Carpenter joined the RPD in March 2005 as a member of the 85th Academy. After graduation, Carpenter was assigned to E Squad in the Southeast District. Carpenter served as a gang liaison officer, and was also assigned to the district's special projects squad and A Squad before being called to serve on an overseas deployment with the N.C. National Guard in 2008. After returning from his tour of duty in early 2010, Carpenter was assigned to the Southeast District's Community Policing Team. Carpenter was raised in Warren County, N.C., and after graduating from high school, he worked for four years as a corrections officer in the N.C. prison system before being called for his first military deployment. Carpenter joined the RPD shortly after he returned from his deployment.

Senior Officer P.G. Manukas has been selected to the Crash Reconstruction Unit. Manukas joined the RPD as a member of the 76th Academy in January 2000. After graduating from the Academy, Manukas was assigned to the Northeast District, and in 2002, he transferred to the Southwest District. After five years on patrol in the Southwest District, Manukas transferred to the North District. Manukas became a Standardized Field Sobriety Test instructor in 2006, completed Drug Recognition Expert training in 2007, and became a DRE instructor for the State of North Carolina in 2008. Manukas, who grew up in central New Jersey, moved to North Carolina in 1996 after earning an associate's degree in criminal justice. He graduated from Campbell University in 1998 with a bachelor's degree in business administration.

Senior Officer J.D. Rattelade, First Class Officer A.D. Johnson, Officer C.M. Erving and Officer K.L. Potter - Southwest District

On January 5, Southwest District C Squad officers responded to a residence on Portree Place in reference to a domestic assault in which the suspect had assaulted the victim and left the scene prior to the officers' arrival. The suspect had a previous criminal record and was escalating in his actions toward the victim. Officers searched for the suspect, but he could not be located. Warrants were drawn on the suspect, and officers continued to look for him throughout the shift. Late that night, the suspect was believed to have surreptitiously returned to the victim's apartment and set a fire. While no one was hurt in the fire, it caused extensive damage to the apartment.

The next day, SWD C Squad Officer J.D. Rattelade took the extra step of composing a basic BOLO for this suspect. Following the tenets of community policing, Rattelade distributed these to convenience stores near the victim's apartment. Later that day, after the end of his shift, SWD C Squad Officer A.D. Johnson was on his way home in his PPV when he noticed a pending "suspicious person" call on his MCT. Despite the broad classification of the call, Johnson read the remarks and discovered that a convenience store clerk who had received Rattelade's BOLO had just seen the suspect. Johnson immediately shared this information with oncoming D Squad units as well as other officers that may have been in the area, and SWD Officers C.M. Erving and K.L. Potter quickly responded to assist. Although the suspect first attempted to conceal himself and then run from the officers, Erving and Potter were able to capture him. The suspect was interviewed by detectives, and additional charges were made for first-degree arson.

The SWD officers in the case are to be commended for their excellent dedication to the apprehension of this dangerous suspect, specifically Officer Rattelade's savvy in extending watchful eyes via the community, Officer Johnson's alertness and attention to detail, and Officers Erving and Potter's rapid and coordinated response to capture the suspect. There is no doubt that these officers' teamwork and relentless effort in apprehending this suspect will prevent additional violence to the victim for some time to come.
